

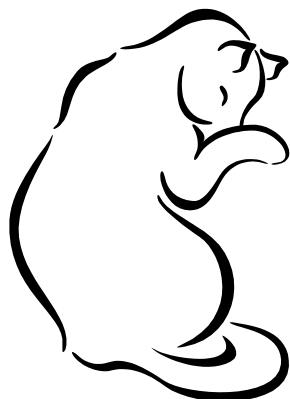

**Cages and Cat Supplies:** Cat litter will be provided. Bring your own litter pans, cat food, dishes, grooming supplies, and cage coverings. For each cat entered the exhibitor gets a half cage which measures 22" x 22" x 22". Exhibitors supplying their own cage will be charged for a double cage. Show rules require that you transport your cat in a carrier.

**Kittens:** All kittens must be at least 4 months old (born on or before July 13, 2021) to enter the show hall and to be shown. Minimum sale price - \$150. No sales cage unless entered.

**Liability:** Neither ACFA, Janesville Allbreed Cat Club, any member of the club nor the Holiday Inn Express will be responsible for loss, damage, injury, or accidents to cats or property or assume liability for injury, loss, damage to any person or property of persons (including, but not limited to exhibitors, judges, vendors, and visitors). We reserve the right to refuse any admission and to remove any person or animal from the show hall in the best interest of the show and exhibitors. Well-behaved children are welcome. Unruly children will be fed to ravenous jackals.

**Health and Condition:** All cats and kittens must have their claws trimmed. We recommend that all cats & kittens be immunized against enteritis, rhinotracheitis, calici, and rabies. If asked to leave because of having sick cats or kittens, or for violation of any ACFA or club rules, your entry fee will not be refunded.
