FINAL SHOW CLOSING DATE: JUNE 10, 2019

PLEASE NOTE : This is really IMPORTANT

- **Because of Kansas State Animal sales laws, KCMCC WILL NOT permit kittens to be sold from our Show Hall.**
- **The Kansas State Animal Health Department MAY REQUIRE presentation of Health Certificates and/or proof of rabies vaccination for any cats in the show hall.**
- **No kittens under the age of four months will be allowed in the show hall.**
- **This show is for the display and competition of cats. Well behaved children and adults are welcome. Unruly children or adults will be asked to leave the Show Hall. NO HEELIES, roller shoes or related foot apparel will be allowed in the show hall.**

Payment must accompany all entries. Make checks payable to **Kansas City Midwest Cat Club**. Entry Clerk will call you in the case of an incomplete or illegible entry form. **NOTE:** A \$25 fee will be charged for all NSF checks. Any overpayments will be donated to the ribbon/rosette fund. There will be no refunds after the June 10th closing date.

FOOD SERVICE: We will have people food available for lunch in the show hall

SHOW HALL: Pottorf Hall, Riley County Fairgrounds, Avery Ave. Manhattan KS 66503. Kansas City Midwest Cat Club and the Riley County Fair Board personnel will exercise all reasonable care, but shall not be held responsible for loss or damage of cat, person, or personal belongings. No animals will be permitted in the show hall unless entered in the show. No cats, kittens, alters, or HHPs will be allowed to remain in the show hall overnight. The club reserves the right to refuse any entry and/or have any animal or person removed from the show hall for any cause deemed not in the best interest of the show (Show Rules Article V, Sec. 6).

SHOW HOURS: Saturday A.M. Check-in 7:00 AM to 8:00 AM, with judging from 8:30 AM to 12:00 PM
Saturday P.M. Check-in 12:00 PM to 12:30 PM, with judging from 1:00 PM to 4:30 PM

HEALTH: This is a non-vetted show. All entries should be inoculated against Feline Enteritis, Feline Rhinotracheitis, Calicivirus, and Pneumonitis before the show. Cats showing any evidence of external parasites, fungus, or other disease will be asked to leave the show hall. If show management deems it necessary to call a veterinarian, the exhibitor will be responsible for any fees.

SUPPLIES: Litter will be provided. Please bring your own litter pans, cat food, and food dishes. KCMCC is attempting to have cat food available, but it is suggested that you bring your own.

CAGES: Single cages are 22" X 22" X 22" and double cages are 22" X 22" X 45". A single cage will be provided with each cat entered in the show. All cats, kittens, alters, and HHPs in the show hall must be assigned a cage. All cages must be covered with cage drapes on the sides, back, top, and floor of the cage.

AWARDS: Ribbons and Awards will be presented in all rings in accordance with ACFA rules. All donations to our ribbon fund will be greatly appreciated.
