

# LITTER REGISTRATIONS

**General Instructions:** Litter registration is encouraged even if no kittens are being individually registered. Individual kitten registrations can be processed more quickly if a litter has already been registered. The Official ACFA Litter Registration Application Form [or a copy] **must** be used.

**Completing The Application:** Please **print** or **type**, except where signatures are required. The application form must be completed and **signed** by the breeder of the litter. The breeder is: [1] the registered owner of record of the Dam on the date of mating or [2] the lessee of the Dam on the date of mating. If the Dam is leased append either: [1] a copy of the lease agreement, [2] a signed lease statement, or [3] complete the lease statement below, complete with required signature(s). All appropriate spaces must be filled in and the application **MUST** contain the number of males/females (indicate how many LH/SH of each sex), date of birth, breed, signature of Breeder, Owner of litter's name(s) and address, signature of the owner of Sire, Breeder's Cattery name and number, if registered with ACFA, and telephone number (in case we have questions).

**Information needed on the Sire and Dam:** The application must contain the full registered name, ACFA registration number [if applicable], breed, color, pattern, eye color and birth date. If ACFA registered parents, then the pedigree information on the rest of the form (sections 3-14) does not need to be completed.

If **Sire or Dam, or both** are **NOT** registered with ACFA, a copy of the registration certificate from the association with which the cat[s] is/are registered **must** accompany the litter registration application. You **must** also: [1] Fill in the 3 generation pedigree of the Sire and/or Dam not registered with ACFA, **COMPLETE WITH FULL REGISTRATION NUMBERS** and the initials of the association in which all cats in the pedigree are registered, or [2] Send a copy of the 3 generation pedigree of the Sire and/or Dam not registered with ACFA, making sure **all cats** in pedigree have **full registration numbers** listed. (NOTE: Bengals not registered in ACFA require a 4-generation pedigree.)
