**SHOW TIMES:** Saturday check-in is 7:30 - 8:30 am; judging begins at 9:00 am. Sunday check-in is 7:30 to 8:00 am.; judging begins at 8:30 am.

**SHOW HOURS FOR THE PUBLIC:** Both Saturday and Sunday 9:00 am - 4:00 pm.

**CLOSING DATE:** Mailed-in entries must be received by July 25th and eclerk registration will close on July 27<sup>th</sup> at 10:00 am or when the 200th entry for each day is received, whichever comes first. If you have not received your confirmation by July 27<sup>th</sup> at 10:00 am, please call or email the entry clerk for confirmation that your entry was received.

**RULES:** This is a non-vetted show: no veterinary inspection will be required prior to benching. The show will be conducted according to the American Cat Fanciers Association (ACFA) show rules which are available for \$7.00 from the ACFA Central Office, P.O. Box 949, Nixa, MO 65714-1949, phone (417) 725-1530. The rules are available on the ACFA website, <http://www.acfacat.com>.

**LIABILITY:** Neither the show management, nor any member of the club, nor the Cat Tales Cat Fanciers Cat Club, Crystal Community Center, nor ACFA, can be held pecuniary liable for the loss of, or accident to: the cats, carriers or other personal property of any exhibitor or injury to any person, animal or property. We reserve the right to refuse any admission and to remove any person or animal from the show hall in the best interest of the show and exhibitors.

**General Information & Sales:** The summary sheet must be returned with all entries and entries fees. No sales Cage unless entered in our show. Kittens must be born on or before April 7<sup>th</sup>, 2024. Show rules state that there will be no kittens less than four months of age allowed in the show hall. No cats or kittens sold for less than \$200, CTCF supports only **SERIOUS BREEDERS**. Kittens & Cats for sale must have proof of litter registration at the show. No sales are permitted from carriers under the table. All household pets over eight months of age must be spayed or neutered. A \$50 insufficient check fee will be assessed if a check is returned for any reason. A \$35 fee will be assessed to their entry fees to anyone who enters the show and does not show up and payment is not received by the show date. If payment is not received letter will go to ACFA and the said exhibitor will not be able to enter any shows until said fees are paid in full.

**CHILDREN:** This show is for the display and competition of cats. While well-behaved children are welcome, if an exhibitor or spectator does bring a disruptive child to the show hall, he or she will be asked to leave. There will be no refund of entry or admission fees.

**HEALTH:** The club strongly advises that all cats and kittens be immunized against feline enteritis, calici virus, rabies, and rhinotracheitis at least three weeks prior to the show. Any animal from a cattery or house where there has been any infectious or contagious illness within 21 days prior to the show will not be allowed in the show hall. Entries must be free of fleas, ear mites and fungus. The show management will remove any cats that show signs of contagious illness or disease. **ALL CLAWS MUST BE TRIMMED; IF CLAWS ARE NOT TRIMMED, IT WILL BE DONE AT THE SHOW AT THE EXHIBITOR'S EXPENSE.** Household pets over 8 months of age must be spayed or neutered.

**SUPPLIES:** The club will provide litter. Bring your own food and water dishes, cat food and litter pans. Single cages (included with entry fee) are 22x22x22. Double cages are 22x22x44. Grooming spaces are 22x22x44. First time exhibitors: Please bring coverings for the top, sides, and bottom of the cage.

**FOOD:** Food truck will be outside the community center

**AWARDS:** The show will be scored for ACFA Inter-American and Regional awards. Cats must be present to receive final wins unless excused by the show manager prior to the closing time of the show.

**TRANSFERS:** Transfers to champion status must be completed with the master clerk during the show on Saturday. NO transfers will be accepted Sunday unless entered for Sunday only. All championship entries should be registered at the time of the show.

**SHOW HALL:** This is a climate-controlled, non-smoking, wheelchair accessible show hall with free parking. No animal may be left in the show hall overnight.
