

Show Times: Check in time 7:30-8:30 AM Saturday and Sunday. Judging will begin promptly at 9:00 AM. All transfers must be completed with the master clerk before leaving the show hall on Saturday evening. Sunday only entries will be the only transfers accepted on Sunday. Show closing will be at 4:00 PM both days. You must be present to accept final awards unless written permission has been received from the show manager.

Show Rules: This show will be conducted according to the ACFA show rules and scored for ACFA Regional and Inter-American awards. It is the responsibility of each exhibitor to know the show rules. Copies of the show rules may be obtained by sending \$7.00 to: ACFA, PO Box 1949, Nixa MO 65174. The rules are available on the ACFA website at http://www.acfacat.com.

Entry Guidelines: The summary sheet must be returned with all entries. No benching unless all fees are paid in full. Post-dated checks will not be accepted. Canadian entries must be paid in U.S. funds. You must be entered in the show in order to request a sales cage. FRVCC supports serious breeders. No cat or kitten may be sold for less than \$125.00. Kittens for sale or entered in the show must be born on or before April 16th-17th, 2025. The show managers can request proof of age. No under-cage or carrier sales will be allowed.

Non-vetted Show: FRVCC strongly advises that all cats and kittens be immunized against Rhinotracheitis, Enteritis, Calicivirus and Rabies at least 3 weeks prior to the show. Any entry from a home or cattery where there has been a contagious disease within 21 days prior to the show is not allowed in the show hall. FRVCC reserves the right to refuse entry. All cats and kittens must have their claws trimmed or a club member, at a cost of \$10.00, will do it. Flea infested cats or kittens will not be tolerated.

Liability: There is not a watchman on duty. Neither ACFA, FRVCC or the Winnegamie Dog Club will be responsible for any injury, loss or damage to any person or property of any individual.

Awards: Awards will be presented in all rings.

<u>Cage/Supplies:</u> Cat litter will be provided. Bring your own litter pans, cat food, dishes and cage coverings. Cage sizes: Single-2lx2l x21. Double-2lx2l x45.

Food/Show Hall: The Lanners Family will be providing food both days for purchase. County ordinance prohibits alcoholic beverages in the club hall. This is a climat-controlled show hall and smoking is <u>NOT</u> allowed. This show is for the display and competition of cats. Well-behaved children are welcome. FRVCC reserves the right to refuse any entry.
