Show Times: Check in time 7:15-7:45 AM Saturday. Judging will begin promptly at 8:00 AM for the AM sessions and 1:00 PM for the PM Session. All transfers must be completed with the master clerk before the start of each session. You must be present to accept final awards unless written permission has been received from the show manager.

Show Rules: This show will be conducted according to the ACFA show rules and scored for ACFA Regional and Inter-American awards. It is the responsibility of each exhibitor to know the show rules. General Information: The summary sheet must be returned with all entries. No benching unless all fees are paid in full. Post-dated checks will not be accepted. A \$50 insufficient check fee will be assessed if a check is returned for any reason. A \$50 fee will be assessed to their entry fees to anyone who enters the show and does not show up and payment is not received by the show date. If payment is not received letter will go to ACFA and the said exhibitor will not be able to enter any shows until said fees are paid in full. IMPORTANT:

Because of Kansas State Animal sales laws, KCMCC WILL NOT permit kittens/cats to be sold from our Show Hall. The Kansas State Animal Health Department MAY REQUIRE presentation of Health Certificates and/or proof of rabies vaccination for any cats in the show hall. No kittens under the age of four months will be allowed in the show hall.

Non-vetted Show: KCMCC/LACF strongly advises that all cats and kittens be immunized against Rhinotracheitis, Enteritis, Calicivirus and Rabies at least 3 weeks prior to the show. Any entry from a home or cattery where there has been a contagious disease within 21 days prior to the show is not allowed in the show hall. KCMCC/LACF reserves the right to refuse entry. All cats and kittens must have their claws trimmed or a club member, at a cost of \$10.00, will do it. Flea infested cats or kittens will not be tolerated.

Liability: There is not a watchman on duty. Neither ACFA, KCMCC/LACF or the Riley County Fairgrounds will be responsible for any injury, loss or damage to any person or property of any individual.

Awards: Awards will be presented in all rings.

Cage/Supplies: Cat litter will be provided. Bring your own litter pans, cat food, dishes and cage coverings. Cage sizes: Single-22” x 22” x 22”. Double-22” x 22” x 44”.

Show Hall: This is a climate-controlled show hall and smoking is NOT allowed. This show is for the display and competition of cats. Well behaved children and adults are welcome. Unruly children or adults will be asked to leave and will not be refunded. NO HEELIES, roller shoes or related foot apparel will be allowed in the show hall. KCMCC/LACF reserves the right to refuse any entry.
